DATA BIBLIOGRAPHY

- In February 1991, The Borough of Ringwood, Borough of Ringwood, February 1991 In February 1991, The Borough of Ringwood adopted its Master Plan that serves as the guide for the community's long-term development strategies. The Borough's commitment to bicycling and walking facilities are most evident in the Traffic and Circulation element of the Plan in which it recommends that all roadways in the Borough be outfitted with these facilities if they are feasible. The Plan also includes a community survey that was done amongst the residents that indicates their desire to have more bicycling paths within the borough.
- 1998 Master Plan Re-Examination Report, prepared by the Ringwood Planning Board and Heyer, Gruel & Talley, PA, Borough of Ringwood, June 1998
 In June 1998, the Borough of Ringwood reexamined its 1991 Master Plan to determine if local planning policies have remained in keeping with the goals and objectives established since the initial adoption of the plan. Based on the reexamination, the document was revised to include goals and objectives that promote the expansion of various recreational facilities throughout the Borough as well as the community's continued commitment to the circulation of bicyclist and pedestrian movement.
- Ringwood Lake Community Speed Surveys around Skyline Lakes Drive, Cupsaw Drive and Lakeview Avenue, Ringwood Police Department, 2004.
 At the request of the community, speed surveys were conducted by the Ringwood Police Department around the areas of Skyline Lakes Drive, Cupsaw Lake and Lakeview Avenue. The surveys were conducted to substantiate the community's desire to reduce the speed limit from 30mph to 25mph and include a three-year history (2001-2003) of crashes for each lake community.
- Municipal Stormwater Management Plan, Borough of Ringwood, January 30, 2005 revision dated March 28, 2005.
 This document outlines Ringwood's strategy to addressing the effects that stormwater may have on the Borough. The document was reviewed to gain background of the current water quality

on the Borough. The document was reviewed to gain background of the current water quality conditions of the waterbodies within the Borough and mitigation solutions for various sites within the Borough.

□ Turning movement data for the intersection of Skyline Drive/Erskine Road, Passaic County Engineering Department, February 27, 2006

The turning movements and volume of vehicles traveling along Skyline Drive and Erskine Road

were monitored by the Passaic County Engineering Department.

In accordance with the New Jersey Municipal Land Use Law, this report serves the Borough's regular reexamination of their current Master Plan and Land Development Ordinances.
