AN ORDINANCE AMENDING CHAPTER 2 -  
ADMINISTRATION - OF THE REVISED ORDINANCES  
OF THE BOROUGH OF RINGWOOD TO PROVIDE  
FOR THE APPOINTMENT OF AN ASSISTANT PUBLIC  
DEFENDER

BE IT ORDAINED by the Municipal Council of the Borough of Ringwood, County of Passaic, State of New Jersey, that Chapter 2 - Administration of the Revised Ordinances of the Borough of Ringwood to provide for the appointment of an assistant public defender, is amended as follows:

1. Section 2:13 - Municipal Public Defender - is amended in its contain the following subsections.

2. Section 2-13.4 - Office of Assistant Public Defender Established; Appointment

The position of Assistant Public Defender is hereby established. The Assistant Public Defender shall be appointed by the Manager for a term of one year.

3. Section 2-13.5 - Qualifications; Duties

The Assistant Public Defender shall be an attorney-at-law of the State of New Jersey and shall perform such duties as assigned by the Municipal Public Defender.

4. Section 2-13.6 - Compensation

The Assistant Public Defender shall receive \$2,500.00 per year as compensation or such compensation as determined by subsequent salary ordinances.

5. Any ordinance or part thereof inconsistent with the terms of this Ordinance is repealed.

6. This ordinance shall take effect 20 days after passage provided by law.
