**AN ORDINANCE TO AMEND CHAPTER 6,
ALCOHOLIC BEVERAGE CONTROL, OF
THE REVISED ORDINANCES OF THE
BOROUGH OF RINGWOOD TO INCREASE
CERTAIN LICENSE FEES**

BE IT ORDAINED, by the Municipal Council of the Borough of Ringwood that Chapter 6, Alcoholic Beverage Control, be amended as follows:

1. Section 6-3.4 - License Fees

The annual fees for the issuance and renewal of alcoholic beverage licenses of the class designated shall be as follows:

Plenary Retail Consumption License	\$621.00
Plenary Retail Distribution License	\$465.00
Club License	\$150.00
Limited Retail Distribution License	\$ 50.00

2. Effective Date

This ordinance shall take effect upon passage and publication as provided by law.
