BE IT ORDAINED by the Municipal Council of the Borough of Ringwood, in the County of Passaic, State of New Jersey that following Section of Chapter 18 - WATER of the Revised Ordinances of the Borough of Ringwood are amended and effective as of March 24, 2014:

D. There are hereby established the following water consumption rates as set forth in Section 18-9.1(d):

QUARTER-ANNUAL WATER RATES

<u>TOTAL QUANTITY IN GALLONS/QUARTER</u>	<u>RATES/QUARTER</u>
0 to 5,000.....	\$36.91 (res. min.)
5,001 to 10,000.....	\$66.23 (res. min.)
Over 10,000.....	\$ 6.62 per 1,000 Gallons

MINIMUM QUARTER-ANNUAL CHARGE OTHER THAN RESIDENTIAL

3/4" and smaller.....	\$73.77
1".....	\$82.23
1 2"	\$97.52
2".....	\$125.41
