

INTRODUCTON

On April 12, 2005 the Passaic County Board of Chosen Freeholders adopted Resolutions amending the Passaic County Site Plan and Subdivision Resolutions and creating the Passaic County Corridor Enhancement program. On July 24, 2008 the Passaic County Planning Board adopted the Passaic County Corridor Enhancement Plan as an element of the Passaic County Master Plan to implement the program. One of the provisions of the Passaic County Corridor Enhancement Program is that the County Planning Director report to the County Planning Board on a yearly basis the estimated cost of Improving intersections within the Paterson-Hamburg Turnpike Transportation Improvement District.

Another one of the provisions of the Corridor Enhancement Plan is that the County Planning Director on a yearly basis submit a written report to the County Planning Board on the status of the Corridor Enhancement Program. The report is to list the amount of money in each district's and intersection's account. The report must also provide a summary of any monies expended from the accounts in the previous year.

The Passaic County Department OF Planning AND Economic Develoepemnt is pleased to present this report in fulfillment of these requirements. A map and chart showing the corridors at the time of the report are included at the end of this report. After reviewing this report, the County Planning Board will fix a date for a public meeting to present an overview of the program and its status.

The Program



In the year ending July 31, 2014, there was an expenditure of \$25,600 from the funds for the West Milford District when the Board of Chosen Freeholders provided a grant to the Township from the Corridor Enhancement Program to purchase a clock. The four-faced clock is 16 feet tall and was installed in a landscaped island at the intersection of Union Valley Road and Marshall Hill Road. The clock will be the centerpiece of the Township's Streetscape Program which will extend two blocks north and west along Union Valley Road and one block east along Marshall Hill Road.


During the past year the Board of Chosen Freeholders also provided a grant in the amount of \$10,000 from the funds for the North Haledon District to purchase two light poles. These will be installed as part of the Borough's Belmont Avenue Streetscape program.

In May the Freeholders used \$10,000.00 from the City of Passaic District as matching funds in partnership with the City through Together North Jersey to fund a riverwalk analysis focusing on the portion of the Passaic River that follows the eastern boundary of the City. The purpose of the riverwalk analysis is to create a model that can be used as a reference for other locations in the County, develop potential solutions for access to the Passaic River and riverfront within the eastside of the City of Passaic, and better understand the feasibility of using Passaic River for recreational uses.

In the coming year, the Freeholders will be adopting amendments to the Passaic County Subdivision and Site Plan Resolutions to extend the benefits of being corridors to all County roads. The County may then be using Corridor Enhancement funds to implement proposals from the Morris Canal, Transportation and other elements of the Passaic County Master Plan that were developed following the principles in the Corridor Enhancement Plan. The City of Paterson Historic Preservation Commission has already submitted a request for a grant from the Corridor Enhancement program to install municipal historic markers at two locations on Grand Street and the Cathedral of St John the Baptist on the corner of Main Street and Grand Street in Paterson.
