AN ORDINANCE AMENDING CHAPTER 7 –
TRAFFIC – SECTION 7-20 – STOP INTERSECTIONS
– OF THE REVISED ORDINANCES OF THE
BOROUGH OF RINGWOOD TO CREATE A STOP
INTERSECTION

BE IT ORDAINED by the Municipal Council of the Borough of Ringwood in the County of Passaic, State of New Jersey, that Chapter 7 – TRAFFIC – SECTION 7-20 of the Revised Ordinances of the Borough of Ringwood be amended as follows:

1. Section 7-20, entitled Stop Intersections, is hereby amended pursuant to the provisions of N.J.S.A. 39:4-140 to include the following intersection. The intersection herein described is designated as a Stop Intersection. A stop sign shall be installed as provided herein:

Intersection

Stop Sign(s) on:

Smokey Ridge Road/Hilltop Road

Hilltop Road

2. The terms and conditions of this Ordinance shall supersede the terms and conditions of any other ordinance inconsistent herewith and the inconsistent terms and conditions shall be deemed repealed by this ordinance.
3. This Ordinance is deemed divisible. In the event any provision is declared void by a Court of competent jurisdiction, the remaining provisions shall remain in full force and effect.
4. This Ordinance shall take effect upon passage and publication as provided by law.
