AN ORDINANCE APPROPRIATING \$330,000  
FROM GENERAL CAPITAL FUND FOR THE  
PURPOSE OF PAVING VARIOUS ROADS IN THE  
BOROUGH

BE IT ORDAINED by the Borough Council of the Borough of Ringwood, County of Passaic, New Jersey as follows:

Section 1. The paving of various roads described in Paragraph 3 of this Ordinance is authorized and declared to be necessary and useful for municipal purposes.

Section 2. There is hereby appropriated for said purposes the sum of \$330,000 from General Capital Fund Balance. Said sum being inclusive of all appropriations heretofore made therefore.

Section 3. That the paving of various roads authorized and the purpose for which this appropriation is made - \$330,000.

Section 4. This Ordinance shall take effect after final passage thereof and publication as prescribed by law.
