The Suburban Trends

WHEREAS, the Borough of Ringwood ("Borough") desires to amend Chapter VIII – Taxicabs and Other Vehicles for Hire, Section 8-3.6 and 8-5.2.

NOW, THEREFORE, BE IT ORDAINED by the Municipal Council of the Borough of Ringwood, County of Passaic, State of New Jersey as follows:

8-3.6 Term of Driver's License; Fee Renewal [TAXICAB DRIVER'S LICENSE]

- a. Every driver's license shall be issued for the calendar year and shall expire on December 31st of each year.
- b. A license fee of fifty (\$50.00) dollars per taxicab driver's license shall be paid. [NEW LANGUAGE] [Currently \$25.00 - since 1985]
- c. No fee shall be refunded because the license applied for is denied. [NEW LANGUAGE]

8-5.2 Fee [LIMOUSINES AND OTHER VEHICLES FOR HIRE]

- a. The fee for the issuance of such license shall be fifty (\$50.00) dollars for each limousine or automobile license. Each vehicle used as a limousine shall be licensed separately. [Currently \$3.00 - since 1985]
- b. The Borough Clerk shall issue such license after the satisfactory compliance by the applicant with the provisions of N.J.S.A. 48:16-13 through 22 and the payment of the aforesaid fee.
