Bogert Municipal Annex, 60 Margaret King Avenue, Ringwood, New Jersey on Tuesday, March 15, 2016, and will be considered for final passage at a Business Meeting of said Municipal Council of the Borough of Ringwood to be held on Tuesday, April 5, 2016 at 8:00 pm, or as soon thereafter as same can be considered, at the Violet E. Bogert Municipal Annex, 60 Margaret King Avenue, Ringwood, New Jersey, at which time and place all persons interested therein or affected thereby will be given an opportunity to be heard concerning same. During the week prior and up to the time of public hearing, copies of said Ordinance will be available to the members of the general public who request same.

BE IT ORDAINED by the Mayor and Council of the Borough of Ringwood, County of Passaic, State of New Jersey as follows:

Section 7-44.2 Issuance of Permits, Fees Transferability shall be amended to modify the permit fees as follows:

- a. *Application for Permit.* A parking permit shall be issued annually for the period **July 1 to June 30** upon application to the Borough Clerk and only upon the display of a current and valid motor vehicle registration certificate for all household vehicles showing the name and address of the applicant and proof of insurance coverage.
- b. *Permit fee.*
 1. Fees shall be one hundred and fifty dollars (\$150.00) per annum. The yearly permit runs **July 1 to June 30**.
 2. For any permit issued for a six-month period, the fee for the six months shall be eighty dollars (\$80.00). The first six month period is **July 1 – December 31**. The second six month period is **January 1 – June 30**.
 3. For any permit issued on a quarterly basis, the fee for each quarter shall be forty-five dollars (\$45.00). The first quarter is **July 1 – September 30**; the second quarter is **October 1 – December 31**; the third quarter is **January 1 – March 31**; and the fourth quarter is **April 1 – June 30**.
 4. For any permits issued on a monthly basis, the fee for the month shall be thirty dollars (\$30.00). The month starts on the first of the month and ends on the last day of the same month.
 5. For any permit issued on a weekly basis, the fee for any week shall be ten dollars (\$10.00). A weekly permit is Monday through Sunday.
