





Air Monitoring Notes:

The VOC alert level exceedance at station C-2 at 9:30 was due to humidity build up on the PID bulb. Station C-2 was located upwind at the time of the alert level exceedance. The reading was confirmed to be false with a handheld PID. The PID bulb and sensor were cleaned and readings returned to below alert levels. No other alert level exceedances occurred
